This announcement is made by International Alliance Financial Leasing Co., Ltd. (the “**Company**”) pursuant to Rule 13.09(2)(a) of the Listing Rules and the Inside Information Provisions (as defined under the Listing Rules) under Part XIVA of the SFO.

Reference is made to the announcement of the Company dated 19 April 2021 (the “**Announcement**”) in relation to the memorandum of understanding of the Possible Acquisition entered into between the Company and Nanshan Group. Unless otherwise defined, capitalised terms used in this announcement shall have the same meanings as those defined in the Announcement.

Pursuant to the MOU, the Due Diligence Review Period commenced from the date of the signing of the MOU and ending on sixty (60) days after signing of the MOU.

As additional time is required for the Due Diligence Review, on 18 June 2021 (after trading hours), the Company and Nanshan Group entered into an extension letter to the MOU, pursuant to which the parties to the MOU have agreed to extend the Due Diligence Review Period for sixty (60) days.

Save as the aforesaid, all other terms of the MOU remain unchanged.

Shareholders of the Company and potential investors should note that the Possible Acquisition is subject to, among other things, the result of the Due Diligence Review, the entering into of a formal agreement, and negotiations of the terms and conditions of**
